### Minimum Entry Fee Purse Guarantee:

1-Day Pro-Am – 45% entry fee or \$30 (whichever is more)  
2-Day Pro-Am – 45% entry fee or \$40 (whichever is more)

### Minimum Sponsorship Purse Guarantee:

1-Day Pro-Am - \$1,000 / 2-Day - \$1,750  
Pro-Lady - \$800  
1-Day Senior Pro-Am - \$1,000 / 2-Day - \$1,500

### Sanction Fees:

\$8.00/player Pro-Am  
\$3.00/player Pro-Lady or Senior Pro-Am  
\$0.00/player Pro-Junior
