I look forward to seeing you, and please join me in thanking those who are supporting our Show. Good luck with your purchasing needs, and I wish you all a very successful season in 2020!

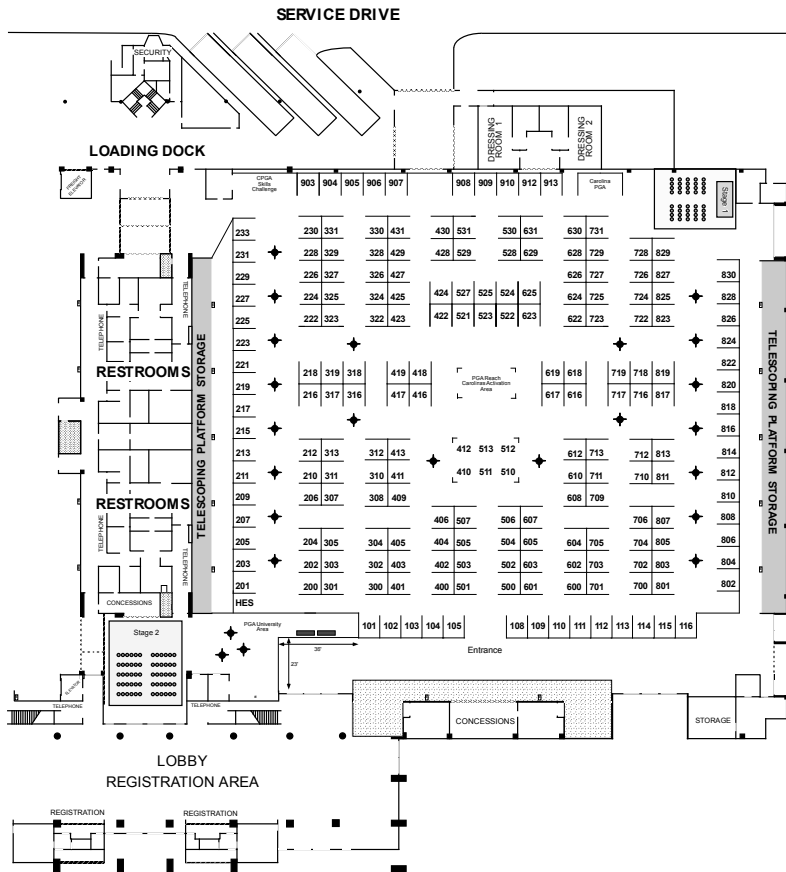
