PGA Professionals affected by Hurricane Ian are eligible for Phase I immediate grants of up to \$1,000 for PGA Members and up to \$500 for PGA Associates. Additional funds of up to \$9,000 for PGA Members are available after November 1, 2022, for PGA Members with devastating losses, based on funds available. To apply for these additional funds, applicants will need to submit a detailed description of the loss with verified receipts with a signed copy of the Phase II Application.

A complete description of your loss, including description and monetary amount such as:

Receipts for evacuation costs (fuel, food, hotel, etc...)

- a. Damage to home and personal property.
- b. Damage to Member-owned business and business property.
- c. Expenses incurred due to the hurricane, such as food, shelter, travel, etc...

IMPORTANT:

When filling out the application and worksheet, receipts for all out-of-pocket expenses for losses, damages, repairs, or other costs not covered by insurance, other relief programs or other means **must be provided along with this application and worksheet.**

Dwelling:

- ✓ Documentation indicating that you are the legal owner of the home (dwelling).
- ✓ Documentation indicating that you are the legal owner of the facility.
- ✓ Declaration page of Homeowners policy showing exceptions/exclusions.
- ✓ If insurance claim will need summary of benefits showing how much the insurance is paying.
- ✓ If insurance denies claim will need a copy of this correspondence.
- ✓ If FEMA claim will need summary of benefits showing how much FEMA is paying
- ✓ If FEMA denies claim will need a copy of this correspondence
- ✓ Pictures, if possible, of before and after damages

Be sure to include disaster relief needs for food, clothing, shelter, or transportation needs, if displaced by the hurricane.

I certify that all the information I have given is true and correct to the best of my knowledge. I have not filed additional applications with the PGA Medical and Disaster Relief Fund for aid to cover the same loss. I will return any disaster aid money I receive from the PGA Medical and Disaster Relief Fund if I receive insurance or money from other organizations such as the Federal Emergency Management Agency for the same loss. I understand that if I intentionally make false statements or conceal information to obtain funds that I may be prosecuted for PGA of America Code of Ethics violations. I authorize and direct all custodians of records of my insurance companies, employer, any public or private agency, bank, financial institution, or credit data service to release information to the PGA Medical and Disaster Relief Fund upon request. If I have insurance that will cover disaster-related expenses, then any money that I receive from the PGA Medical and Disaster Relief Fund will be considered an advance.
