



2024 Carolinas PGA Cash Drawing Official Rules & Regulations

The following document outlines the official rules and regulations affiliated with the Carolinas PGA Section's cash jackpot drawing to be hosted during the 2024 Carolinas PGA Annual Merchandise Show taking place Monday, February 19, 2024 – Tuesday, February 20, 2024, as approved by Carolinas PGA Legal Counsel.

- **Members earn 1 PDR each day for participating.**

ELIGIBILITY

Carolinas PGA Professionals with codes that fall in the “**Eligible**” category below are allowed to participate. Those in the “**Not Eligible**” category are not allowed to participate:

Eligible

- Class A Professionals (A-1 thru A-24)
- Life Member Retired (LMR)
- Life Member Retired Master Professional (LMMR)
- Life Member Active (LMA)
- Life Member Active Master Professional (LMMA)
- Life Member Century (LMC)
- Master Professional (MP)
- Retired Member (RM)
- Unemployed Members [In good standing – not Class F or Reserve]

Not Eligible

Individuals in the following categories are not eligible to participate:

- Associates (B1-B24; Unemployed Associates)
- Suspended (F)
- Reserve
- Non-Carolinas PGA Members

ENTRY & OPPORTUNITIES TO PARTICIPATE

Carolinas PGA Professionals will have at least three (3) total opportunities to enter their names into the drawing.

Opportunities to participate include:

- Annual Meeting Pre-Registrants receive one (1) entry into the drawing. Carolinas PGA Professionals who pre-registered for the 2024 Annual Meeting by the advertised deadline of Friday, February 9 at 4 PM EST are automatically entered into the drawing.

Late Annual Meeting registrants are not eligible for this entry in the drawing

- MONDAY, February 19, 2024: There will be one (1) additional opportunity for Carolinas PGA Professionals to enter their names into the drawing by receiving a “Front 9 Hole Scorecard” at the CPGA booth and visiting nine (9) randomly assigned merchandise show booths. After acquiring initials from a representative at each of the nine (9) assigned booths, the individual will return the card to the CPGA booth for an entry into the drawing.
- TUESDAY, February 20, 2024: There will be one (1) additional opportunity for Carolinas PGA Professionals to enter their names into the drawing by receiving a “Back 9 Hole Scorecard” at the CPGA booth and visiting nine (9) new randomly assigned merchandise show booths. After acquiring initials from a representative at each of the nine (9) assigned booths, the individual will return the card to the CPGA booth for an entry into the drawing.
- The Carolinas PGA reserves the right to offer additional random opportunities throughout the merchandise show to earn entries into the drawing.

DRAWING & ANNOUNCEMENTS

PRIZE DRAWING: Monday and Tuesday, February 19 and 20, 2024

The official drawing and awarding of the \$7,500 cash jackpot prizes will be awarded as follows:

On Monday, February 19, 2024 at approximately 4:30 PM EST:

- (1) The first entry will be drawn for a \$1,500 cash prize

On Tuesday, February 20, 2024 at approximately 1:30 PM EST:

- (1) The first entry will be drawn for a \$1,000 cash prize
- (2) The second entry will be drawn for a \$1,000 cash prize
- (3) The third entry will be drawn for a \$1,000 cash prize
- (4) The fourth entry will be drawn for the grand prize of \$3,000

The entries from the “pot” will be selected at random during this time. Each winner’s name will be announced from the show floor center stage podium in the following manner: “NAME, going once” “NAME, going twice” “NAME, going three times.” If by the third announcement, the winner is not present (i.e. within 25 feet of the podium), another name will be selected and announced.

****Winners must be present on the show floor (East Wing Exhibit Hall) in order to accept the prizes****

PRIZES

The winners’ prizes will be delivered via ACH payment within fifteen (15) business days of the award-winning announcements. Winners must have a Workday account with ACH routing set up prior to the payment being issued by the Carolinas PGA.
